Pursuant to CASR 91, PT. Smart Cakrawala Aviation is hereby authorized to operate the aircraft identified above for the purpose of aircraft Weather Control. All operations of the aircraft must be in accordance with the following restrictions and limitations:

1. No person may operate this aircraft for other than purpose of Weather Control. This document shall be onboard for pilot purpose. In addition, this aircraft shall be operated in accordance with these operating limitations are part of the DGCA Form No. 21-24, Special Certificate of Airworthiness, and shall be carried in the aircraft at all time.
2. No person may operate this aircraft for Carrying persons or property for compensation or hire.
3. No person may be carried on a restricted category civil aircraft unless that person :
 - a. Flight crew member;
 - b. Flight crew member trainee;
 - c. Performs an essential function in connection with a special purpose operation for which the aircraft is certificated; or
 - d. Necessary to accomplished the work activity directly associated with that special purpose.
4. No person may operate a restricted category civil aircraft within Indonesia a. Over densely populated area;
 - a. In a congested airway; or
 - b. Near a busy airport where passenger transport operations are conducted.
5. The pilot of this aircraft shall hold a valid pilot license.
6. All instruments and equipment installed and used shall be inspected and maintained in accordance with the requirement of CASR. Any inspection or maintenance of this equipment must be recorded in the aircraft maintenance records.
7. This Aircraft shall be covered by insurances as defined in the Aviation Act Number 1, Year 2009.
8. This aircraft does not meet the requirement of applicable, comprehensive and detail. Airworthiness code as provided by Annex 8 of the International Civil Aviation Organization (ICAO). The owner/operator of this aircraft shall obtain written permission from other country's Civil Aviation Authority (CAA) prior to operating this aircraft in or over that country.

Catatan : (1) Setiap orang yang mengoperasikan pesawat udara yang tidak memenuhi standar kelaiakudaraan sebagaimana dimaksud dalam Pasal 34 dipidana dengan pidana penjara paling lama 3 (tiga) tahun atau denda paling banyak Rp. 1.500.000.000,00 (satu miliar lima ratus juta rupiah).

Note : (1) Anybody operating an aircraft without fulfilling airworthiness standard as meant in Article 34 shall be condemned with imprisonment for a maximum 3 (three) years or a fine of a maximum Rp. 1,500,000,000.00 (one billion and five hundred million ruplahs)

Sertifikat Kelaikudaraan Khusus ini dikeluarkan berdasarkan Undang-Undang Republik Indonesia No. 1 Tahun 2009 tentang Penerbangan dan Peraturan Keselamatan Penerbangan Sipil (PKPS).
This Special Certificate of Airworthiness is issued pursuant to the Republic of Indonesia Aviation Law No. 1 Year 2009 and Civil Aviation Safety Regulations (CASR).

Sertifikat Kelaikudaraan Khusus ini menetapkan kewenangan-kewenangan dan batasan-batasan bagi pembuat / operator pesawat udara yang tertera di dalam sertifikat ini untuk melakukan uji terbang.

Tidak diijinkan melakukan uji terbang apabila :

- (1) Membawa orang atau barang-barang lainnya.
- (2) Membawa orang yang tidak diperlukan dalam pelaksanaan uji terbang.

This Special Certificate of Airworthiness established the authorities and limitations to builder / operator of the aircraft stated in this certificate to perform flight testing.

No person shall perform flight testing, if:

- (1) Carry person(s) or other articles.
- (2) Carry person(s) not required for the purpose of flight testing.

- 2) Terbang melintasi wilayah negara lain tanpa mendapat persetujuan dari negara tersebut.

This Special Certificate of Airworthiness states that the described aircraft has been inspected and found to be in compliance with related requirements of the Civil Aviation Safety Regulations (CASR) for the issuance of Special Certificate of Airworthiness. The described aircraft has not comply with all requirements of approved Type Design and other applicable airworthiness standards of ICAO Annex 8 to the Convention on International Civil Aviation.

No person may operates aircraft as described in the front page of this certificate:

- (1) Unless it comply with related requirements of the CASR for the operation of aircraft with Special Airworthiness Certificate and is in safe condition to be operated and is within the operating limitations imposed by Director General of Civil Aviation as part of this certificate.
- (2) Flying over other country without permission from that country.
