Pursuant to CASR 91, PT. Smart Cakrawala Aviation is hereby authorized to operate the aircraft identified above for the purpose of aerial surveying. All operations of the aircraft must be in accordance with the following restrictions and limitation:

1. No person may operate this aircraft for other than purpose(s) of Aerial Surveying. This document shall be onboard for pilot purpose. In addition, this aircraft shall be operated in accordance with applicable air traffic and general rules of CASR part 91 and all additional limitation herein prescribed under the provision of CASR PART 91.313. These operating limitations are part of the DGCA FORM 21-24, Special Certificate of Airworthiness, and shall be carried in the aircraft at all time.
2. The pilot of this aircraft shall hold a valid pilot license and trained for special purpose operation.
3. Except for take of landing, no person may operate this aircraft over densely populated area or in congested airways.
4. The pilot of this aircraft shall notify air traffic control of the Special C of A for Restricted Category of this aircraft when operating into or out of airport with an operational control tower.
5. No person may operate this aircraft for carrying persons or property for compensation or hire.
6. The pilot of this aircraft shall advice each person carried of the restricted category of this aircraft and explain that it does not meet the certification requirement of a standard certificated aircraft.
7. The aircraft shall be operated in accordance with the approved Standard Operating Procedure (SOP) for Aerial Surveying of PT. Smart Cakrawala Aviation, Revision 00 date November 2017.
8. This Aircraft must display the word RESTRICTED in accordance with CASR part 45.23(b) in addition, the nationality and registration mark must be displayed in accordance with CASR part 45.
9. All instruments and equipment installed and used shall be inspected and maintained in accordance with the requirement of CASR. Any inspection or maintenance of this equipment must be recorded in the aircraft maintenance records.
